Seventeen mission teams, with 169 participants, served in Honduras. These teams built 10 homes for families, conducted 64 community feedings, installed 58 water filters, built 43 latrines and 44 pilas. They painted 4 schools, conducted 2 vacation bible schools, 3 medical classes and a medical brigade. Education programs thrived in 2024. Thirty students graduated from the 11th grade and 22 students graduated from the 9th grade. Twenty-three Right Weigh God's Way classes were conducted. One level 1 English class program was completed, one level 2 English class was completed, and sixty students completed a basketball sports camp. The first segment of the school was built was on the Honduras Compassion Partner's campus. Continued on Schedule O.
